## **An Announcement from the Office of the Mayor Coronavirus COVID-19 Response Local Update**

**January 20, 2021**

Our Haledon Community:

As your Mayor, I regret to inform you about the 22<sup>nd</sup> death of a Haledon resident due to complications of Coronavirus (COVID-19). My thoughts and prayers remain with everyone affected by this pandemic. As of this writing, there have been 868 confirmed cases of COVID-19 in the Borough of Haledon. We must continue to wear our masks, practice social distancing, and wash our hands frequently. I would also like to bring the following to your attention:

- The Governor has expanded COVID-19 vaccine eligibility to include residents 65 and older and anyone 16 to 64 with chronic medical conditions. COVID-19 vaccines are being distributed to hospitals and clinics across New Jersey. You can reserve your spot to get a vaccine by pre-registering. You will be asked some questions to determine when you are eligible to receive a vaccination. You and your family may pre-register at <https://covidvaccine.nj.gov>
- Our neighbors at the Brownstone, located at 351 West Broadway, continue administering COVID-19 testing in their parking lot on West Broadway in Haledon. COVID-19 testing at this site will be available to the public, including Haledon residents. Beginning on Monday, January 18, 2021, testing at this site will be available seven (7) days a week from 9AM to 4PM. There will be no cost for testing. However, if you have insurance, you are required to bring it with you. In order to be tested, you must pre-register at [covidcarenj.com](https://covidcarenj.com);
- Please be reminded of the Executive Order limiting indoor gatherings to 10 persons, except for religious services/celebrations, political activities, wedding ceremonies, funerals, or memorial services, where the number of attendees is limited to 25 percent of the capacity of the room in which the event takes place, but regardless of the capacity of the room, such limit shall never be larger than 150 persons. Outdoor gatherings are limited to 150 persons.
- The Governor also issued an Executive Order directing all restaurants, bars, clubs, and lounges that serve food and drinks to close their indoor premises for business by 10PM each day and they cannot open until at least 5AM the following day. In addition, sitting at a bar is also prohibited. Outdoor dining, takeout, and delivery services may continue past 10PM;
- Furthermore, the Governor also issued an Executive Order authorizing counties and municipalities to order nonessential businesses to close at 8PM to help slow the spread of this second wave of COVID-19. My COVID-19 Response Team will be closely monitoring our COVID-19 statistics and our business social distancing regulations. As of right now, our restaurants and bars will remain open until 10PM; however, should our numbers increase at an alarming rate and/or social distancing protocol violations become a concern, we may have to resort to an 8PM closing out of an abundance of caution;

- The Walgreens located at 441 Belmont Avenue continues to offer no-cost, contactless COVID-19 rapid drive-thru testing in partnership with the PWNHealth provider network. Testing is available at no cost between 9AM and 5PM. Based on CDC guidance, you should get tested if you develop symptoms of COVID-19 within 14 days of having close contact with that person or if that person later tests positive for COVID-19. Close contact includes being within 6 feet of an infected person for a cumulative total of 15 minutes or more over a 24-hour period, starting from 2 days before illness onset until the time the infected person is isolated;
- In cooperation with the State of New York, New Jersey launched a contact tracing app called "COVID Alert NJ". This app, which keeps users' identities anonymous, are based on a new technology developed by Google and Apple;
- Passaic County Board of Chosen Freeholders has partnered with Vault Health to offer FREE Covid-19 testing at home for all of our residents. The physician-ordered, provider-supervised and physician-reported saliva collection test for COVID-19 has the same effectiveness as the swab test. This test is performed under the supervision of a Vault healthcare provider through a video telehealth visit eliminating the risk of person-to-person exposure to the virus. To register for your at-home testing kit, you must first fill out the form below to verify your Passaic County residency. Immediately following your submission, you will receive a link to receive your kit. This is FREE to all Passaic County residents, and health insurance is not required. Please note: This is not an antibody test. This test is designed to determine if you currently are infected with COVID-19 and have the potential to infect others. - Our health officials continue seeking medical professionals to assist with COVID-19 Contact Tracing. - The Passaic County Health Department continues to administer COVID-19 mobile testing throughout Passaic County please visit <https://www.passaiccountynj.org> for more information regarding mobile testing. Although you must be a Passaic County resident, you do not need a prescription to be tested;
- Please be reminded that the Governor signed an Executive Order requiring the wearing of masks/face coverings whenever social distancing is not practical.
